2. I hereby acknowledge that an animal may, without warning or any apparent cause, stumble, bite, run, make unpredictable movements, jump obstacles, step on a person's feet, or push or shove a person – all which may cause an attendee to fall or be injured.
3. As the host, you voluntarily assume the risk and danger of injury or death inherent while engaging in any and all activities involving the animals associated with Woofs and Wags Pet Sitting.
4. As a party host, you are responsible for any damages to the property caused by your guest.
5. Parties are held regardless of weather conditions. In the event of severe weather, we reserve the right to curtail or cancel the scheduled event.
6. A 50% non-refundable deposit is required with your reservation. The remaining balance is due 24 hours before the event is to be held. Cancellations less than 48 hours before the event will require the remaining balance to be paid in full.
7. I acknowledge and agree to the rental fee based on my package selection above. I have agreed to reserve the rental above on the designated date and time above. If the event date changes after the reservation is confirmed, I acknowledge that I may lose my deposit if the new date that is chosen is unavailable.
